### CARIBBEAN POISON INFORMATION NETWORK (CARPIN) 2000-2006 JOURNEY

### **GENESIS AND HISTORY**

The concept of a Poison Information Center originated in the year 2000, from the collaborative work of the Authors of a book entitled "Poisonous Plants of Jamaica". Dr. Henry Lowe, Professor Errol Morrison, Professor Kenneth Magnus and Ellen Campbell-Grizzle were the authors.

In 2001, the Caribbean Association of Pharmacists under the presidency of Ellen-Campbell-Grizzle gave its support to the concept.

During 2001-2002, the concept of regional development and training was further strengthened, when five countries initially committed to gather and disseminate poison information. The five countries were: Trinidad and Tobago, Barbados, Suriname, Grenada and Jamaica. Other countries expressing interest include: St. Lucia, St. Vincent, Guyana and the Bahamas

Trinidad and Tobago launched their Poison Control Centre in 2002. Dr. Eugenie Brown-Myrie and Dr. Jean Williams-Johnson, who attended the launch, were part of a group trained to use the International Programme on Chemical Safety (IPCS)-INTOX software. Since then, IPCS of W.H.O, Switzerland has been providing training and software for data gathering

In the same year, the book Poisonous Plants of Jamaica was launched simultaneously with the Poison Network, in Jamaica.

CARPIN's Management Committee held its first meeting on the 31<sup>st</sup> January, 2003 at the University of Technology, Jamaica. At that meeting Mr. Michael Tucker, Executive Director of the National Council on Drug Abuse (NCDA) was selected chairman and Dr. Jean Williams-Johnson, Medical Director of the Emergency Unit, University Hospital of the West Indies (UHWI), was appointed secretary.

The greatest challenge which faced the Committee was funding for the project. Interim suggestions included:

### **Human Resource**

Representatives from the collaborating Organizations could offer personnel as volunteers for three (3) months.

#### Location

University of Technology committed to housing of the Centre in the Faculty of Health and Applied Science

### Contributions and Collaborations

The project was to be reviewed and collaborators commit based on resources, for example, specialized skills.

Collaborating organizations represented at that January meeting were:

Several proposals for funding were prepared and submitted to agencies and donors. The National Health Fund, the last in the series, of funding agencies approached bought into CARPIN's vision, to be the recognized repository and facilitator of poison information within the Caribbean. CARPIN's mission being to make poison information readily available through a network of sentinel sites throughout the region/countries of the Caribbean and increase awareness of poisoning, the dangers and management of poison cases.

During the interim period, hope remained alive with the use of limited resources available, and the continued support of the Caribbean Association of Pharmacists

Through the kind support of Mr. Glen Christian, Cari-Med Limited, a graduate from the Pharmacy Programme at UTech, Ja., Mr. Carlisle Howsen was employed at the Centre in the summer of 2004.

The Education Sub-committee which had been established earlier in the year, worked hand in hand with Mr. Howsen to plan the first Poison Prevention Week, September 26,-October 1, 2004. This event, however, did not take place due to the passage of Hurricane Ivan.

CARPIN was approved by the Pharmacy Council of Jamaica as an internship site for three (3) months rotations, but funding was not in place for salaries. Regrettably, we lost the services of Mr. Howsen when he moved on to another organization for Internship.

In November of 2004, Dr. Ligia Fructhengarten of IPCS, residing in Brazil, trained a group of persons in the use of the IPCS-INTOX software. This training was held at the University of Technology, Jamaica.

With the National Health Fund approved funding for the project over a three (3) year period, early 2005, the Regional Nerve Centre was launched during Poison Prevention Week May 12-13, 2005. The Management Committee with special support from the representatives from University of Technology, Ja. and National Council on Drug Abuse ensured the success of the week.


### POISONINGS FROM A CARIBBEAN PERSPECTIVE

### What is the situation in the Caribbean?


- A retrospective review of the charts of all patients <13 years old admitted to the Children's Ward at Holberton Hospital in Antigua for accidental poisoning between March 1989-1999
- 255 admissions. 115 (45%) were in 1-year-old, 69 (27%) 2-year-old children, and 26 (10%) were in 3-year-old
- Rate of admission 1.3 per 1,000
- Data were compared with data from Barbados, Guyana, Jamaica, and the USA
- Similar to the age patterns seen in the other countries
- They also found that as economic levels rose, there was a shift in the substances ingested, (from hydrocarbon and plant--> chemical and medication)
- The recommendation called for establishment of a poison control center for the English-speaking Caribbean.

### **CASES REPORTED TO THIS NERVE CENTER**

### 2005 Case Report

- CARPIN receives several reports of poisoning each year both intentional and accidental, as well as from rural and urban areas.
- These include pesticides, herbs, drugs, food poisoning and even insect bites.
- From August-December 2005 a total of 13 cases of poisoning were reported.
- Five (5) of these were reported to the UHWI while eight (8) were reported to the CARPIN.
- Three (3) were intentional and the others were accidental.
- Five (5) of the cases were children <4 years old while five (5) were adults ages 18-60 yrs. No age was recorded for the other three (3) cases.
- CARPIN also gets requests from health care providers such as doctors and pharmacists regarding patient management in cases of poisonings as well as information on statistics of poisonings.


